Sanction is accorded to felling of 961 trees/poles at V.W.L Bijarni of Social Forestry Division, Doda located at Km 7th (RD 150 to RD 235) coming under the alignment of road from Beoli-Gaddi in Doda District, being constructed by Executive Engineer PMGSY Division, Doda, Subject to the following conditions:-

1. The User Agency shall pay the following amount after the forest clearance is accorded :

i.	Compensation of 961 T/P	Rs. 2,00,910/-
ii.	Cost of damage to fencing	Rs. 29,360/-
	TOTAL	Rs. 2,30,270/-

2. The extraction of 961 trees/poles shall be done by the State Forest Corporation/ Forest Department, on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the user agency.

3. The User Agency shall construct retaining walls/breast walls and take all necessary steps to check soil erosion which may result due to proposed construction of the road. The User Agency shall seek technical guidance in this respect from the Director, J&K Soil Conservation Department.

4. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.

5. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the Office of Pr. Chief Conservator of Forests, J&K.
