Sub: - Diversion of 55.04 hac. of Forest Land for laying of 132 KV D/C Bran-Siot-Kalakote T/L by PDD.

Sanction is hereby accorded to diversion of 55.04 hac. of Forest Land from Compartments No. 2,11,12,21,23 & 38/K, 30,31b,41,43,44,45,46,47 & 118a/D,156,158,159 & 160/K of Jammu Nowshera and Rajouri Forest Divisions in District Jammu, on following terms and conditions: -

- I. The Proprietary status of Forest land shall remain unchanged.
- II. The Forest land shall be utilized only for the purpose for which it has been indented.
- III. The Forest land in question shall not be mortgaged, reassigned or sub-leased by user agency in any manner whatsoever to any other agency.
- IV. The user agency shall pay the following amount: -

i	Net Present Value	=Rs. 4,24,21,300/-
ii	Compensation for 787 T/P & 867 Bushes	=Rs. 32,24,749/-
iii	Compensatory Afforestation	=Rs. 28,00,000/-
Total		4,84,46,049/-

- V. The user agency shall also abide by the following.
 - i. Below each conductor, width clearance of 03 Mtr. Would be permitted for taking tension stringing equipment
 - ii. In the remaining width of Corridor, tree will be felled or lopped to the extent required for preventing electrical hazards by maintaining a minimum clearance between conductors and trees as 4.00 Mtr.

iii. In the stretches where terrain is hilly and adequate clearance is already available, trees will not be cut

- VI. The Extraction of 787 Trees/Poles and 867 Bushes shall be done by the State Forest Corporation on the basis of the markings technically sanctioned by the Conservator of Forests and administratively approved by the Chief Conservator of Forests concerned.
- VII. The user agency shall not be allowed to dump the debris (resulting from excavation of foundation for the towers) on Forest land.
- VIII. Any damage done to the Forest land/Crop shall be charged @ 10 times the standard rate of 1992.
- IX. The Forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the user agency and after it is rehabilitated properly by the user agency.
- X. The user agency shall be responsible for obtaining requisite clearances under any other Law in vogue.
- XI. No Khair Tree is allowed to be felled. 58 Khair Trees enumerated shall be deleted from the proposal with the corresponding reduction in compensation amount of trees enumerated in the same.
- XII. For avoiding felling of Khair Trees coming in the proposed alignment for transmission line necessary modification /change shall be effected by the user agency in consultation with the Forest department.

XIII. The possession of the Forest land diverted for non forestry purpose above shall not be handed over to the user agency till all payments due on account of NPV/compensation of land, compensatory afforestation costs, are deposited with the Chief Accounts Officer in the Office of the Principal Chief Conservator of Forests J&K. Before handing over the possession of the land in question it should further be ensured that there are no outstanding dues with the said user agency in respect of the cases sanctioned in the past.
