Sanction is hereby accorded to allow felling of 769 trees/ poles growing in strip plantation coming in the alignment / widening of Road from Satwari to Kunjwani by PWD(R&B) Construction Division-1 Jammu in Social Forestry Division Jammu, subject to the following terms and conditions:-

- 1. The proprietary and legal status of forest land shall remain unchanged.
- 2. The Government land shall be utilized only for the purpose for which it has been indented.
- The Government land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.

The User Agency shall pay the following amount:-

- 7. Any damage done to the forest by the User Agency or its employees. and contractors or people employed by them shall be charged from User Agency @ 10 times the standard rate of 1992.
- 8. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User * Agency.

9. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.

10. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the office of Pr. CCF, J&K.
