Proposal to allow use of 4.2 Ha. of forest land for construction of road from Tathamulla to Bujthanian by R&B Department in J.V. Forest Division Baramulla.

Sanction is hereby accorded to use of 4.2 Ha. of forest land for construction of road from Tathamulla to Bujthanian by R&B Department in Compartment 22/Boniyar, Block Lagama, Range Boniyar, J.V. Forest Division, District Baramulla, subject to the following terms and conditions:-

- 1. The proprietary and legal status of forest land shall remain unchanged.
- 2. The forest land shall be utilized only for the purpose for which it has been indented.
- The forest land shall not be mortgaged, reassigned, leased or subleased by user agency in any manner what so ever to any other agency.

4. The User Agency shall pay the following amount:-

i	Net Present Value	₹ 37,67,400/-
ii	Compensatory Afforestation	₹ 7,05,360/-
iii	Compensation of trees/poles/saplings	₹ 10,20,180/-
	Total:-	₹ 54,92,940/-

5. (a) Number of trees / poles / saplings involved:-

(b) The extraction of the trees shall be done by the State Forest Corporation/Social Forestry Department on the basis of markings administratively approved by the Chief Conservator of Forests, Kashmir. The cost of extraction and transportation shall be borne by the User Agency.

- 6. The User Agency shall construct retaining walls/breast walls as per approved plan and design and take all necessary steps to check soil erosion, which may result due to proposed construction. The User Agency shall seek technical guidance in this respect from the Director, J&K Soil Conservation Department. A copy of the plan and design of the proposed Road shall be made available to the Forest Department.
- 7. The User Agency shall not dump the debris on forest land and it shall be dumped on separate dumping sites. Area of dumping sites will be included for additional diversion by the User Agency.
- 8. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from User Agency @ 10 times the standard rate of 1992.
- The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User Agency.
- 10. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.
- The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the office of Pr. CCF, J&K.
- 12. The Forest Department will enquire into the circumstances which led to the violation of the Forest Conservation Act, take action against the defaulter and inform the Forest Advisory Committee accordingly.
