Sanction is hereby accorded to use of 0.05 Ha. of forest land for installation of water pipe line for troops by 33 RR Bn (58 GR) in Compartment No's: 31/N to 35/N of Lamberi Range of Nowshera Forest Division, subject to the following terms and conditions:-

- 1. The proprietary and legal status of forest land shall remain unchanged.
- 2. The forest land shall be utilized only for the purpose for which it has been indented.
- 3. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay the following amount:-

- Number of Trees and Poles involved: Nil.
- 5. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User Agency.
- 6. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.
- 7. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited with Chief Accounts Officer in the office of Pr. CCF, J&K through cheque / Demand Draft.
