Revised Proposal to allow use of 0.020 Ha. of forest land for Providing Communication facilities at Poshpathri instead of Bradimarag by BSNL in Sindh Forest Division.

Sanction is hereby accorded to use of 0.020 Ha. of forest land for Providing Communication facilities at Poshpathri instead of Bradimarag by BSNL in Compartment No: 63a/Sindh of Sindh Range of Sindh Forest Division, subject to the following terms and conditions:-

- 1. The proprietary and legal status of forest land shall remain unchanged.
- 2. The forest land shall be utilized only for the purpose for which it has been intended
- 3. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
- 4. The User Agency shall pay the following amount:-

Net Present Value	₹13,980/-
Total:-	₹ 13,980/-

- Number of Trees and Poles involved: Nil.
- 5. No permanent construction of the building shall be allowed at the proposed site.
- 6. The User Agency shall not dump the debris on forest land other than allowed for use.
- 7. The User Agency shall take all necessary steps to check soil erosion which may result due to excavation of the foundation of the tower.
- 8. Any damage done to the Forest by the User Agency or its employees and contractors or people employed by them shall be charged from User Agency @ ten times the standard rate of 1992.
- 9. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User Agency.
- 10. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue.

11. The money on account of various heads to be paid by the User Agency as detailed above shall be deposited through Cheque /Demand Draft with Chief Accounts Officer in the office of Pr. CCF, J&K.
