Sanction is hereby accorded to felling of 30 trees/poles of Robinia and Poplar and looping of 52 trees/poles of Robinia of Social Forestry Department for laying of 33 KV Transmission Line from village Nowshera to Lower Jehlum H.E. Project by PDD, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount:-

i. Compensation of Trees/ poles	₹ 55,000/-

(b) The extraction of the trees/ poles shall be done by the State Forest Corporation/Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department. The cost of extraction and transportation shall be borne by the User Agency.

3. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning the project.

4. The cheque/ draft amounting to ₹ 55,000/- on account of Compensation of trees shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.


