1. The User Agency shall pay the following amount:-

2. Number of Trees /Poles / Saplings involved: Nil.
 3. The cheque/ draft amounting ₹ 6900/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
 4. The User Agency shall not dump the debris on forest land.
 5. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User Agency.
 6. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.

7. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning the project.
8. The proprietary and legal status of forest land shall remain unchanged.
9. The forest land shall be utilized only for the purpose for which it has been indented.
10. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
