Sanction is hereby accorded to use 0.705 hectare of State land under the possession of Shri Mata Vaishno Devi Shrine Board (SMVDSB) and recorded as "Gair Mumkin Jungle" for permanent diversion of Katra-Reasi road in connection with construction of Banganga Bridge (Railway Bridge No. 32 at Km. 28.250) by Northern Railway in Reasi Forest Division, subject to the following terms and conditions:-

- (b) The extraction of the trees/ poles shall be done by the State Forest Corporation/Forest Department on the basis of markings administratively approved by the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be borne by the User Agency.
- 3. The Forest Department by adopting mechanized and improvised ways shall ensure that the young saplings involved are not damaged and safely transplanted (with ball of earth) in the adjoining area with provision of protection and after-care under CAMPA
- 4. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning the project.
- 5. The cheque/ draft amounting to ₹ 4,86,615/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
- 6. The proprietary and legal status of land shall remain unchanged.
- 7. The land shall be utilized only for the purpose for which it has been indented.
- 8. The land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
