Subject: - Proposal to allow use of 0.50 hectare of Strip Plantation area at Awantipora and Glander Pampore Units of Social Forestry Department coming in the four-laning of NH-1A by NHAI.

Sanction is hereby accorded to use 0.50 hectare of Strip Plantation area at Awantipora and Glander Pampore Units of Social Forestry Department coming in the four-laning of NH-1A by NHAI in Strip Plantation of Social Forestry Division, Pulwama, at (i) Awantipora at Km. 29 from Srinagar to Jammu, (ii) Glander Pampore at Km. 15 from Srinagar to Jammu, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of project:-

I	Net Present Value	₹ 3,49,500/-
II	Compensation of trees/ poles	₹ 10,07,520/-
III	Compensatory Afforestation	₹ 1,06,000/-
Total:-		₹ 14,63,020/-

2. (a) Number of Trees / Poles/ Saplings involved:

Species	Trees (30-40cm & above)	Poles (20-30cm & 10- 20cm)	Saplings (0-10cm)	Total

- (b) The extraction of the trees/ poles shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.

3. The User Agency shall construct retaining walls/breast walls as per approved plan and design of the project and take all necessary steps to check soil erosion which may result due to proposed construction of the road. Any technical guidance required may be obtained from the Soil Conservation Department J&K.
4. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
5. The cheque/ draft amounting to ₹ 14,63,020/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
6. The land shall be utilized only for the purpose for which it has been indented.
7. The User Agency, at their expenses, shall plant all the small sized Poplar poles in the area under ROW by the mechanized means and ensure their maintenance and watch & ward.
