

## GOVERNMENT OF JAMMU AND KASHMIR CIVIL SECRETARIAT, FOREST DEPARTMENT

Proposal to allow use of 0.90 hectare of forest land for construction of Mini Secretariat (Administrative Block) at

Mendhar by PWD (R&B) in Poonch Forest Division.

64.02 of 64th meeting of Forest Advisory Committee).

Sanction is hereby accorded to use 0.90 hectare of forest land for construction of Mini Secretariat (Administrative Block) at Mendhar by PWD (R&B) in Poonch Forest Division, (the land involved is a Forest Nursery near Bus Stand, Mendhar), subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of project:-

2. (a) Number of Trees / Poles/ Saplings involved:

Trees Poles Sapling (20-30cm & **Species** (30-40cm & (0-10cm)Total 10-20cm) above) Broad Leaved Tun, Robinia, 74 329 68 187 Ulmus, Safeda, Melia, Khirik, Harhi

(b) The extraction of the trees/ poles shall be done by the State Forest Corporation/State Forest Department on the basis of markings administratively approved by the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be borne by the User Agency.

- 3. The User Agency shall not be allowed to execute the work till the equivalent non- forest land as proposed by the District Administration is transferred to the Forest Department in lieu of forest land allowed for use.
- 4. The Forest Department by adopting mechanized and improvised ways shall ensure that the young saplings involved are not damaged and safely transplanted (with ball of earth) in the adjoining area with provision of protection and after - care under CAMPA.
- 5. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning the project.
- 6. The cheque/ draft amounting to ₹ 9,18,230/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
- 7. The forest land shall be utilized only for the purpose for which it has been indented.
- 8. The Forest Department shall develop the nursery (under CAMPA) at the site proposed to be transferred by the District Administration and shall shift all the nursery plants there before the User Agency is allowed to start the work on forest land.
