Subject: - Proposal to allow use of 0.646 hectare of Village Woodlot area of Social Forestry Department for laying of 132 KV D/C Transmission Line from Badampora to Bandipora by Power Development Department.

Sanction is hereby accorded to use of 0.646 hectare of Village Woodlot area of Social Forestry Department for laying of 132 KV D/C Transmission Line from Badampora to Bandipora in Kreshav Village Wood Lot (VWL), Safapora (Ganderbal) of Social Forestry Division, Srinagar by Power Development Department, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of project:-

i	Net Present Value	₹ 4,51,554/-
ii	Compensation of trees/poles/saplings	₹ 1,27,806/-
iii	Corridor stocking	₹ 45,220/-
Total:		₹ 6,24,580/-

2. (a) Number of Trees / Poles/ Saplings involved:

Species	Trees (30-40cm & above)	Poles (20-30cm & 10-20cm)	Saplings (0-10cm)	Total
Broad -Leaved Robinia, Aillanthus	-	223	129	352

(b) The extraction of poles/ saplings shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.

3. Felling of trees/ poles shall be done only where it is unavoidable, otherwise pruning and lopping shall be allowed to prevent electrical hazards by way of maintaining the minimum clearance of 4.0 meter between conductors and trees/ poles.
4. Corridor of 0.646 hectare under the T/L shall be restocked by the Social Forestry Department with herbs, shrubs and small sized trees of medicinal value for which the Indenting Agency shall provide ₹ 45,220/- to the Department.
5. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
6. The cheque/draft amounting to ₹ 6,24,580/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
7. The land shall be utilized only for the purpose for which it has been indented.
