Sanction is hereby accorded to use of 6.2 hectare of Social Forestry Units area with felling / lopping permission of 1103 trees/ poles coming in the corridor of 400 KV D/C Kishenpur –Srinagar- Wagoora Transmission Line in favour of PGCI Ltd, in Social Forestry Units near village Hollina of Social Forestry Division Ramban:

1. The User Agency shall pay the following amount prior to execution of project:-

- The extraction of trees/poles shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.
- Felling of trees/ poles shall be done only where it is unavoidable, otherwise pruning and lopping shall be allowed to prevent electrical hazards by way of maintaining the minimum clearance of 5.5 meter between conductors and trees/ poles.
- The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- The corridor of 6.20 hectare under the T/L shall be restocked by the Social Forestry Department with herbs, shrubs and small sized trees of medicinal value for which the Indenting Agency shall provide ₹ 4,34,000/- to the Department.
- The cheque/draft amounting to ₹ 69,92,265/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
- The proprietary and legal status of land shall remain unchanged.
- The land shall be utilized only for the purpose for which it has been indented.
- The land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
