Sanction is hereby accorded to use of 0.48 hectare of forest land for restoration of Wangath Link Canal of Upper Sindh Hydel Project (Stage-II), Kangan, by JK SPDC in Compartment No: 35/ Mbl of Sindh Forest Division, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of project:-

Note: - The trees/ saplings involved are not required to be felled/ cut but these will be effected due to hydrological impact and eventually may die.

- 3. The Forest Department by adopting mechanized and improvised ways shall ensure that the young saplings involved are not damaged and safely transplanted (with ball of earth) in the adjoining area with provision of protection and after-care under CAMPA.
- 4. The User Agency shall construct retaining breast/ walls around the dumping sites and ensure that the debris dumped is rammed properly using machines/ implements so that it does not get washed away and is stabilized / rehabilitated properly. This should further be consolidated by planting soil binding species of grass and other vegetation.
- 5. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
- 6. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning the project.
- 7. The cheque/ draft amounting to ₹ 11,77,360/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.

8. The proprietary and legal status of forest land shall remain unchanged.

- 9. The forest land shall be utilized only for the purpose for which it has been indented.
- 10. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
