Sanction is hereby accorded to use of 2.107 hectare area of different Units of Social Forestry Department and felling permission of 2024 trees/poles coming in the four laning of NH-1A of Jammu – Udhampur Section (Km. 36 to Km. 52.400 and Km. 0 to Km. 1.00 of Udhampur Bypass) by NHAI in Social Forestry Units of Salora –I, Salora-II, Tikri-Mand VWL, Manoor strip and Garnia-II VWL of Social Forestry Division, Udhampur, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of project:-

i	Net Present Value	₹ 19,78,475/-
ii	Compensation of trees/poles/saplings	₹ 16,92,745/-
iii	Compensatory Afforestation	₹ 2,94,980/-
iv	Cost of damage to fencing	₹ 1,18,720/-
v	Avenue plantation	₹ 1,02,900/-
Total:		₹ 41,87,820/-

- (b) The extraction of trees/poles shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.
3. The User Agency shall construct retaining walls/breast walls as per approved plan and design of the project and take all necessary steps to check soil erosion which may result due to proposed construction of the road. Any technical guidance required may be obtained from the Soil Conservation Department J&K. The Forest Department shall take due cognizance under law for any laxity on this account on the part of the User Agency which might trigger soil erosion in the area.
 4. The Social Forestry Department shall take up avenue plantation of three strips with effective fencing on either side of the NH-1A under CAMPA
 5. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
 6. The User Agency shall get project formulated by the Social Forestry Department for the road side Avenue Plantation on either side of the NH-1A through-out the State.

7. The cheque/draft amounting to ₹ 41,87,820/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
8. The land shall be utilized only for the purpose for which it has been indented.


