Sanction is hereby accorded to use of 0.118 hectare strip plantation of Social Forestry Department for development of Park along bund parallel to ERA Nallah adjoining to Rajinder Nagar Housing Colony, Jammu in Rajinder Nagar (Phase -II) by JDA, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of Project:-

i	Compensation of saplings	₹ 14,380/-
ii	Cost of damage to barbed-wire fencing	₹ 36,360/-

3. The Social Forestry Department by adopting mechanized and improvised ways shall ensure that the young saplings are not damaged and safely transplanted (with ball of earth) in the adjoining suitable area ensuring appropriate safeguards for their protection and after-care under the resources available. It shall be the responsibility of the DFO concerned to ensure that transplantation exercise is completed and compliance to this effect is reported with full details to his higher ups.
4. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
5. The cheque/ draft amounting to ₹ 50,740/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
