- (b) The extraction of trees/ poles shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.
- 3. The Social Forestry Department shall identify suitable area along the track for rail side plantation and formulate the project to be processed and implemented under CAMPA.
- 4. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- 5. The cheque/draft amounting to ₹14,04,800/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K...
- 6. The land shall be utilized only for the purpose for which it has been indented.
