Subject: - Proposal to allow use of 3.399 hectare of forest land for laying of 33 KV Transmission Line from Mandal (Kishtwar) to Padyarna by JK SPDC in Kishtwar Forest Division.

Sanction is hereby accorded use of 3.399 hectare of forest land for laying of 33 KV Transmission Line from Mandal (Kishtwar) to Padyarna by JK SPDC in Compartment No: 65/K, 20 c/N, 16/N, 17/N & 12/N of Kishtwar Forest Division, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of Project:-

i	Net Present Value	₹ 30,48,903/-
ii	Compensation of trees/poles	₹ 6,57,647/-
iii	Establishment of NWFP Unit	₹ 10,00,000/-
Total:-		₹ 47,06,550/-

2. (a) Number of Trees / Poles/ Saplings involved:

- (b) The extraction of the trees/ poles shall be done by the State Forest Corporation/State Forest Department on the basis of markings administratively approved by the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be borne by the User Agency.
3. **The Forest Department by adopting mechanized and improvised ways shall ensure that the young saplings/ seedlings/ recruits are not damaged and safely transplanted (with ball of earth) in the adjoining suitable area ensuring appropriate safeguards for their protection and after-care under the resources available. It shall be the responsibility of the DFO concerned to ensure that transplantation exercise is completed prior to extraction of trees/ poles and compliance to this effect is reported with full details to his higher ups.**
4. **The User Agency shall ensure the following while laying the transmission line through the forest land:-**
- i) Below each conductor, width clearance of 3 meter would be permitted for taking the tension stringing equipment. The trees/ poles on such strip would have to be felled but after stringing work is completed, the natural regeneration will be allowed to come up.
 - ii) In the remaining width of the corridor i.e., 2.5 meter, trees/ poles will be felled, pruned or lopped to the extent required for preventing electrical hazards by maintaining the minimum clearance of 2.8 meter between conductor and trees/ poles.
 - iii) In the hilly terrain where adequate clearance is already available, trees will not be cut.
5. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
6. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User Agency.

7. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
8. The cheque/ draft amounting to ₹ 47,06,550/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
9. The proprietary and legal status of forest land shall remain unchanged.
10. The forest land shall be utilized only for the purpose for which it has been indented.
11. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
