1. The User Agency shall pay the following amount prior to execution of the project:-



3. The land shall be utilized only for the purpose for which it has been indented.
4. The extraction of the trees/ poles shall be done by the State Forest Corporation/Soil Conservation Department on the basis of markings administratively approved by the Director, Soil Conservation Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.
5. The User Agency shall construct retaining walls/breast walls as per approved plan and design of the project and take all necessary steps to check soil erosion which may result due to proposed construction of the road. Any technical guidance required may be obtained from the Soil Conservation Department J&K. The Soil Conservation Department shall take due cognizance under law for any laxity on this account on the part of the User Agency which might trigger soil erosion in the area.
6. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
7. (a) The User Agency shall clear FCA outstanding amounting to Rs. 7,21,09,442/- for the cases sanctioned earlier.
(b) The CCF, Kashmir, shall pursue with Revenue authorities for assessment of compensation of land in the earlier cases of Project SAMPARK (Kashmir Province)
(c) This is in line with the assurance given by the Commissioner/ Secretary (Forests) to the CAG Public Accounts Committee in the meeting held on 10.11.2012.
8. The cheque/ draft amounting to Rs. 10,83,570/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.




