Sanction is hereby accorded to use of 0.356 hectare of Soil Conservation Units of the Soil Conservation Department for construction of Gandala to Jakhar road by PMGSY Department in Gangera and Jakhar Soil Conservation Units of Soil Conservation Department in District Udhampur, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of Project:-

i	Net Present Value	₹ 2,33,890/-
ii	Compensation of trees/ poles	₹ 21,450/-
iii	Cost of damage to Barbed-wire fencing and DRSM works	₹96,100/-

- 3. The extraction of the trees/ poles shall be done by the State Forest Corporation/Soil Conservation Department on the basis of markings administratively approved by the Director, Soil Conservation Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.
- 4. The User Agency shall construct retaining walls/breast walls as per approved plan and design of the project and take all necessary steps to check soil erosion which may result due to proposed construction of the road. Any technical guidance required may be obtained from the Soil Conservation Department J&K. The Soil Conservation Department shall take due cognizance under law for any laxity on this account on the part of the User Agency which may trigger soil erosion in the area.
- 5. Any damage done to the Soil Conservation Units (other than allowed for use) by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
- 6. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- 7. The cheque/ draft amounting to ₹ 3,51,440/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
- 8. The area involved of the Soil Conservation Units shall be utilized only for the purpose for which it has been indented.
