**Subject: - Proposal to allow use of 0.90 hectare of Social Forestry Units of the Social Forestry Department coming under 400 KV S/C Uri –II to Wagoora Transmission Line of the PCGI Ltd.**

Sanction is hereby accorded to use of 0.90 hectare of Social Forestry Units of the Social Forestry Department coming under 400 KV S/C Uri –II to Wagoora Transmission Line of the PCGI Ltd. in Four Social Forestry Units of Social Forestry Division, Baramulla, at four locations near villages Noorkah, Sultan Dhaki and Izara, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of Project:-

i	Net Present Value	₹ 6,29,100/-
ii	Compensation of trees/poles	₹ 2,44,920/-
iii	Compensatory Afforestation	₹ 1,40,000/-

2. (a) Number of Trees / Poles/ Saplings involved:

**Note: -** (i) Trees/ poles shall be felled to the extent required whereas in the rest only lopping and pruning shall be allowed.

(ii) Saplings shall not be damaged till they grow tall and infringe the transmission line when only lopping and pruning shall be allowed.

(b) The extraction of the trees/ poles shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.

3. ***The User Agency shall ensure that the trees/ poles will be felled, pruned or lopped to the extent required for preventing electrical hazards by maintaining the minimum clearance of 5.5 meter between conductors and trees/ poles. In no case the saplings shall be damaged, however, when they grow tall and infringe the transmission line, the lopping and pruning may be allowed.***

4. Any damage done to the Social Forestry Units (*other than allowed*) by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.

5. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.

6. (a) *The User Agency shall clear old FCA outstanding amounting to ₹ 16, 33,500/- for the PGCIL cases sanctioned earlier in Kashmir Region.*

(b) *The CCF, Kashmir, shall pursue with the Revenue authorities for assessment of cost of land in the earlier cases wherever required.*

(c) *This is in line with the assurance given by the Commissioner/Secy. (Forests) to the CAG Public Accounts Committee in the meeting held on 10-11-2012.*

7. The cheque/ draft amounting to ₹ 10,14,020/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.

8. The land shall be utilized only for the purpose for which it has been indented.
