Sanction is hereby accorded to use of 6.62 hectare of forest land for construction of road from Majua to Resan by PMGSY Department in Compartment No: 24/N Ramnagar Forest Division, subject to the following terms and conditions:-

1. The User Agency shall pay the following amount prior to execution of Project:-

i	Net Present Value	₹ 43,49,340/-
ii	Compensation of trees/poles/ saplings	₹ 11,90,050/-
iii	Compensatory Afforestation	₹ 9,26,800/-
iv	Cost of damage to fencing	₹ 2,78,670/-
v	Cost of transplantation of saplings	₹ 50,000/-
vi	Road side avenue plantation	₹ 50,43,200/-
Total:-		₹ 1,18,38,060/-

- (b) The extraction of the trees/ poles/saplings shall be done by the State Forest Corporation/State Forest Department on the basis of markings administratively approved by the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be borne by the User Agency.
3. The User Agency shall construct retaining walls/breast walls as per approved plan and design of the project and take all necessary steps to check soil erosion which may result due to proposed construction of the road. The Forest Department shall take due cognizance under law for any laxity on this account on the part of the User Agency which might trigger soil erosion in the area.
 4. ***The User Agency shall execute the work after the Social Forestry Department and the Forest Department have transplanted the saplings involved in the adjoining/ nearby Closures.***
 5. The User Agency in view of the reduced Road Land Width shall get the DPR revised and approved by the competent authority prior to the execution of the project.
 6. ***The User Agency shall not be allowed to dump the debris on forest land and shall exercise utmost care and caution for dumping the debris on non-forest land so that the adjoining plantation of the Forest Department and the Social Forestry Department is not damaged. Further, for the muck dumping sites identified on non-forest land, it shall be the responsibility of the User Agency to ensure eco-restoration of such muck dumping sites through engineering and biological means and by keeping due provision in the revised DPR of the project for the same.***
 7. Any damage done to the forest or the adjoining plantation by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
 8. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency and after rehabilitated properly by the User Agency.
 9. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.

10. The cheque/ draft amounting to ₹ 1,18,38,060/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
11. The proprietary and legal status of forest land shall remain unchanged.
12. The forest land shall be utilized only for the purpose for which it has been indented.
13. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
