Sanction is hereby accorded to use of 29.13 hectares of land for construction of 850 MW RATLE HEP, Drabshalla by Jammu Kashmir State Power Development Corporation (JKSPDC) in Block Kishtwar, Social Forestry Division, Kishtwar, subject to the following terms and conditions:-

- (b) The extraction of the trees/ poles shall be done by the State Forest Corporation/ Divisional Forest Officer concerned on the basis of markings administratively approved by the Director, Social Forestry Department. The cost of extraction and transportation shall be paid by the User Agency directly to the agency executing the extraction.
- 2. Any damage done to the forest on the environment by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
