Subject: Use of 0.19 hectare of forest land for construction of Shed for Water pump/DG Set and Water Sump by Indian Air Force in Poonch Forest Division.

Sanction is hereby accorded to use of 0.19 hectare of forest land for construction of Shed for Water pump/DG Set and Water Sump by Indian Air Force in Compartment No. 250/S, Blok Samote, Range Surankote of Poonch Forest Division subject to the following terms and conditions:

- i. The proprietary and legal status of forest land shall remain unchanged.
- ii. The forest land shall be utilized only for the purpose for which it has been indented.
- iii. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
- iv. Forest land will be handed over to the User Agency only after payment of following amount to the Forest Department. Cutting of bushes will not be allowed till full payment is made:-

i	Net Present Value	₹ 1,24,830/-
ii	Compensation of 25 Bushes	₹ 5,000/-
iii	Compensatory Afforestation	Nil
Total:-		₹ 1,29,830/-

- v. (a) Number of Bushes = 25 Nos.
(b) The extraction of the bushes shall be done by the State Forest Corporation/ Forest Department on the basis of administrative approval of the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be borne by the User Agency.
- vi. The User Agency shall construct retaining walls/breast walls as per approved plan and design of the project and take all necessary steps to check soil erosion which may result due to proposed construction of the shed and water sump. The Forest

Department shall take due cognizance under law for any laxity on this account on the part of the User Agency which might trigger soil erosion in the area.

- vii. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
- viii. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- ix. The cheque/ draft amounting to ₹ 1,29,830/- on account of various heads as detailed above shall be deposited with the Chief Accounts Officer in the office of the Principal Chief Conservator of Forests, J&K.
