Sanction is hereby accorded to felling of 79 trees/poles coming under widening of road from Bikram Chowk to Women College Gandhinagar, Jammu by J&K, Economic Reconstruction Agency (ERA) in Social Forestry Division Jammu, subject to the following terms and conditions:

(i) Work shall be allowed only after payment of following amount to the forest Department. Extraction of Trees/Poles will not be allowed till full payment is made:

Compensation of trees/poles	₹ 3,79,380/-

(a) Number of Trees / Poles / Saplings involved.

(b) The extraction of the trees/ poles shall be done by the State Forest Corporation/ Divisional Forest Officer concerned on the basis of markings administratively approved by the Director, Social Forestry Department. *The cost of extraction and transportation shall be paid by the User Agency directly to the agency executing the extraction.*

(ii) Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.

(iii) The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
