(ii) Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.

(iii) The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
