- (b) The extraction of trees/ poles shall be done by the State Forest Corporation/ Social Forestry Department on the basis of markings administratively approved by the Director, Social Forestry Department, J&K. The cost of extraction and transportation shall be borne by the User Agency.
- (iv) The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- (a) The User Agency shall clear FCA outstanding amounting to (v) ₹ 32,09,68.213/- (as on ending March, 2013) for the PWD(R&B) cases sanctioned in Jammu Region.
 - (b) The CCF. Jammu, shall pursue with the Revenue authorities for assessment of cost of land in the earlier cases wherever required.
 - (c) This is in line with the assurance given by the Commissioner/ Secretary (Forests) to the CAG Public Accounts Committee in the meeting held on 10-11-2012.
- The Social Forestry Department Shall take up aversa (vi) plantation along the length of the road by 100 number of Teak and Mango Plants whereas the user agency shall provide 100 number of "Tree Guards" for the protection of these Plants.
