Sanction is hereby accorded to the use of 29.75 hectare of forest land for construction of 560 MW Kwar HEP by the CVPP Pvt. Ltd. in Compartments No. 3c/N, 16/ N & 17/ N, Block Chirool - I, Chirool - II, Puller Range Nagseni of Kishtwar Forest Division subject to the following terms and conditions:-

The proprietary and legal status of forest land shall remain unchanged. (i)

The forest land shall be utilized only for the purpose for which it has been indented under (ii) close supervision of the concerned Forest Department Officers.

The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in (iii) any manner what so ever to any other agency.

The User Agency has paid the following amount prior to execution of the project:-

- The extraction of the trees/ poles shall be done by the State Forest Corporation/ DFO concerned on the basis of markings administratively approved by the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be done by the User Agency directly to the agency executing the extraction.
- The User Agency shall execute the work after the Forest Department has transplanted the (vi) saplings involved in the nearby Closure/Nursery.
- The User Agency shall be responsible for the eco-restoration of the muck dumping sites through engineering and biological means as proposed in the Muck Disposal Plan. (vii)
- The User Agency shall execute the work only after the environment clearance of the (viii) project is obtained from the Ministry of Environment and Forests.
- User Agency shall undertake a comprehensive catchment area treatment plan and it will be responsible for proper Muck disposal at specified location and its proper compaction (ix)and consolidation with engineering and vegetative methods.
- Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the (X)standard rate of 1992.
- The forest land so allowed for use shall return to the Forest Department free of any (xi) encumbrances when it is no longer required by the User Agency.
- The User Agency shall be responsible for obtaining requisite clearances under any other (xii) law in vogue before commissioning of the project.
