The above approval is subject to the following terms and conditions:-

- i. The forest land shall be utilized only for the purpose for which it has been intended, that too under close supervision and periodical spot inspection of the concerned Forest Department Officers. The reports of the concerned DCF shall be submitted to the FAC Cell in the the office PCCF with copies to the Administrative Department.
- ii. Construction, if any, will be allowed on forest land only after payment of amount summarized below to the Forest Department and Government sanction is issued in the case:-

i.	Compensation of trees	Rs. 1.37,000
	Total	Rs. 1.37,000

- iii. The extraction of the trees/poles shall be done by the State Forest Corporation/Divisional Forest Officer concerned on the basis markings administratively approved by the Chief Conservator of forests, Jammu. The cost of extraction and transportation shall be paid by the User Agency directly to the agency executing the extraction.
- iv. The user Agency shall take all necessary steps to check soil erosion which may result due to proposed works in consultation with the Soil Conservation Department.
- v. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.
- vi. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the Project.

- vii. The sanction will remain valid for one year and in case the due amount against the project summarized above is not paid within this stipulated period, the sanction shall be deemed to be cancelled.




