Sanction is, hereby, accorded to the use of 0.1 hectare of forest land for construction of Shelter Shed at Margan Top Kokernag by Kokernag Development Authority (KDA) in Anantnag Forest Division subject to the following terms and conditions:-

- 1. The proprietary and legal status of forest land shall remain unchanged.
- The forest land shall be utilized only for the purpose for which it has been indented, that too under close supervision and periodical spot inspection of the concerned Forest Department Officers. The reports of the concerned DCF shall be submitted to the FAC Cell in the office of Principal Chief Conservator of Forests, J&K with copies to the Administrative Department.
- 3. The forest land shall not be mortgaged, reassigned, leased or sub-leased by the user agency in any manner whatsoever to any other agency.
- 4. Construction, if any, will be allowed on forest land only after payment of amount summarized below is made to the Forest Department and Government sanction is issued in the case:

Number of Trees / Poles/ Saplings involved is 'Nil'.

5. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rate of 1992.

- 6. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.
- 7. The User Agency shall be responsible for obtaining requisite clearances under any other law in vogue before commissioning of the project.
- 8. The sanction will remain valid for one year.
