- 1. The land involved shall be utilized only for the purpose for which it has been indented.
- 2. The user Agency has made the payment in full of the amount summarized below, as reported by the Nodal Officer, FCA, vide letter mentioned at Ref. (iv).

- 3. The extraction of the trees/ poles shall be done by the State Forest Corporation/ Social Porestry Department on the basis of markings administratively approved by the Director, Social Forestry Department. The cost of extraction and transportation shall be borne by the User Agency.
- 4. The User Agency, in addition to the usual engineering measures prescribed in the DPR such as retaining walls, breast walls, side drains etc., shall also include the equally important road side avenue plantation all along the length of the road and for this, the user agency shall get the DPR accordingly revised and approved by the competent and only before execution of the project.
