1. The proprietary and legal status of forest land shall remain unchanged.
2. The forest land shall be utilized only for the purpose for which it has been indented, that too under close supervision and periodical spot inspection of the concerned Forest Department officers. The report of the concerned DCF shall be submitted to the FAC Cell in the Office of Principal Chief Conservator of Forests, J&K, with copies to the Administrative Department

3. The forest land shall not be mortgaged, reassigned, leased or sub-leased by user agency in any manner what so ever to any other agency.
4. Any damage done to the forest by the User Agency or its employees and contractors or people employed by them shall be charged from the User Agency @ 10 times the standard rates.
5. The User Agency and or its contractors will not bring any forest area under their use, other than the actual area / activity approved by the Government for the instant proposal. Any laxity or deviation on this account by the user agency or its contractors will attract penal provisions of the relevant Acts /legal provisions.
6. The Sanction will remain valid for one year.
