

On the recommendations of the J&K Services Selection Board and in pursuance to the directions issued by the Principal Chief Conservator of Forests & HoFF Jammu and Kashmir vide communication No. PCCF/NG/Estt/7463530/2295 dated: 01-08-2024, the below named candidate, who has been selected against the District Cadre posts of **Kupwara District** in terms of Advertisement Notification No. 04 of 2022 dated: 27-07-2022 (Item No: 184), is hereby temporarily appointed as **Driver Grade-II (Junior Grade Driver)** in the Pay Level-2 (₹. 19,900 – 63,200) with effect from the date of his joining against the post. The appointment of the above said candidate shall be subject to the fulfillment of the following conditions: -

- A. The appointee will report to the Controlling Officer mentioned here-in-before within a period of 21 days from the date of issue of this order for further adjustment. In case the appointee fails to join at his respective place of posting


- within prescribed period of 21 days, it shall be presumed that he is not interested in joining the Department and the order of appointment in respect of the candidate shall be deemed to have been cancelled ab-initio without giving any further notice as provided in Circular No. 08 -JK-(GAD) of 2019 dated: 04-12-2019;
- B. The appointee shall be allowed to join only on production of the following documents / certificates, in original, to be verified subsequently: -
1. Date of Birth Certificate (Matriculation);
 2. Academic / Qualification Certificate(s);
 3. Domicile Certificate issued by the concerned Competent Authority;
 4. Physical Fitness Certificate from the Chief Medical Officer of the District;
- C. **The appointment of the above named candidate as Driver-II - Junior Grade Driver - (District Cadre Kupwara) shall further be subject to the following conditions: -**
- i. The appointee shall give an undertaking in the shape of an affidavit **(as per annexure to this Order)** to the effect that if on verification, his Qualification / Date of birth Certificates from the concerned issuing authorities, are found fake / forged, his appointment as Driver-II - Junior Grade Driver - (District Cadre Kupwara) shall be deemed to have been cancelled ab-intio and the legal action as warranted under rules shall be initiated against him;
 - ii. That if the candidate has taken loan for self-employment from DIC / Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of Unit / enterprise and also stakes, if any, in such self-employment Unit / enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishments of proprietorship and stakes, if any, in such a self - employment unit / enterprise and recovery to be made and also personally monitor its recovery;
 - iii. **The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of guinness of Qualification and Date of Birth Certificates is received from the concerned Authorities / Agency;**
 - iv. The appointee shall be on probation for a period of two years;
 - v. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated: 24-12-2009;
 - vii. The appointee shall retain his lien in the concerned District Cadre;
 - viii. The appointment of the above named candidate is subject to the outcome of writ petition(s), if any, pending before Competent Court of Law;
