- i. Academic Qualification Certificates (Matriculation and above), Category certificates, Meritorious certificates wherever applicable, of the promotee(s) be verified/ authenticated from the respective quarters/Institutions, ensuring that such authentications are obtained confidentially;
- ii. The concerned Drawing & Disbursing Officer shall satisfy himself / herself regarding the genuineness of the basic appointment of the promotee(s);
- iii. Non-involvement of the promotee(s) in any damage, shortfall, outstanding or embezzlement case and intimation to this office if found contrary for necessary action under rules including forfeiture of promotion.
- iv. In the event the claimed qualification, category certificate and the basic appointment of the promotee(s) proves to be otherwise, in addition to forfeiture of promotion, legal action as warranted under rules should be taken.

The promotees shall remain on probation for a period of two years.

The promotion of the above officials shall be subject to outcome of writ petition (s) pending, if any before the court (s) of Law.
