

The appointment of the above candidates shall be governed as per the provisions of SRO 400 of 2009 dated:-24-12-2009. DFO Urban Forestry Division will allow the appointee to join only after checking/verification of following original documents/ certificates:-

1. Date of Birth Certificate (Matriculation)
2. Permanent Residence Certificate
3. Qualification Certificates.
4. Category Certificate(if applicable)
5. Certificate from the District Industries Centre concerned to the effect that the candidate has not availed any loan under self employment scheme.
6. Certificate from the Deputy Director Employment concerned to the effect that the candidate is not employed in any Government Department or Semi-Government Organisation.

The appointee will submit his joining within 21 days from the date of receipt of the appointment order failing which, his appointment shall be deemed to have been cancelled in ab-initio without giving any further notice in this regard.

The appointment shall also be governed as per provision of the SRO 335 of 1991 Dated:-28-11-1991 and his salary shall be drawn and disbursed by the DDO only after satisfactory character and antecedents certificate received from CID (J &k Police Deptt.)
