Combined Tentative Seniority List of Class-IV Officials (Ministerial/Executive Category) of District Shopian (borne in Forest Division Shopian) born on schedule cadre (Orderly, Farash, Chowkidar, Mali, Cattle Pond Keeper, Boat Mazdoor, Chain Man, Water Carrier, Road Mazdoor, Mapper, Watcher, Jamadar & Gardener) as it stood on 01-01-2022 forming annexure to this notification is hereby notified for information of all concerned officials. The seniority list has been prepared as per the rules laid down for determining the seniority and the gist of such rules which have been followed in drafting of this seniority list is as under:-

(I) The date from which the seniority is to be reckoned is based on:-

- i. The date of appointment.
- ii. Confirmation.
- iii. Regularization of services.
- iv. Length of services; or
- v. On any other reasonable basis.

In absence of any rule, length of continuous officiation is a valid principle for determining the seniority (*G.P Govaltv. Govt. of U.P. AIR 1984 SC 1527*)

(II) Further the Hon'ble Supreme Court has laid down the following broad guidelines for determining the seniority:-

- a) Where the persons were promoted to the permanent post on officiating basis, they would be treated at par with those appointed to permanent posts in substantive capacity for the purpose of fixing seniority.
- b) The seniority is related to the length of 'continuous service' except such service which is not a period of fortuitous, stop gap or adhoc appointment.
- c) The interse-seniority depend on the date of entry in the grade where the seniority is fixed according to rules on the length of service in that grade, it is implied that the services to be counted from the date of entry into the service. It does not matter much when the seniority list was prepared.
- d) An act of confirmation does not amount to fresh appointment but merely to setting the seal of approval on an appointment already made (*D.K Mitra Vs Union of India AIR 1985 SC 1558*).

III. Rule 24 of the Classification Control & Appeal Rules-1956 says that the seniority of a person has reference to the service, class, category or grade with reference to which the question has arisen and that such seniority shall be determined by the date of his first appointment in such class, service, category or grade as the case may be. In matter of promotion and seniority, it is substantive



post that matters. So where a public servant does not hold such post, he is not entitled to the seniority (*G.R Baqual Vs State of J&K AIR 1970 SC 1376*).

IV. When two or more Government employees are appointed on the same date, their seniority is to be determined on the basis of their age (*Sudama Singh Vs Nath Saran Singh AIR 1988 SC 84*).

The same factor has been adopted in this list in respect of those who have been regularized on the same date but not provided with the date of engagement, which is mandatory for determining the seniority position.

The Seniority list shall however be subject to outcome of the writ petition(s), if any, pending before the court of law. The date of birth/Service bio-data/qualification as mentioned in the seniority list is always provisional and shall be subject to further verification by the DDO concerned. Any official not satisfied with his service biodata/seniority position or having any objection, shall submit representation through the DDO concerned with documentary evidence duly recommended, which should reach this office within 21 days from the date of issuance of this Notification. Any representation/objections received beyond the prescribed time, shall not be entertained and final seniority list shall be issued accordingly.




