After scrutinizing Service Book details, it has been found that the official was initially regularized against the post of Helper in DFO Resources & Survey Division, Jammu. The representation of the official is considered and his name has been placed at the appropriate place i.e., S. No. 3 in the Category of Helpers in the Final Seniority List.

4. **Representations of Sh. Pawan Kumar, Watcher and Sh. Manoj Kumar, Lab Boy received through DCF Agrostology Division, Jammu vide No. Ag/J/Estt./1073-74 dated 13-11-2023 for incorporation of their names in the final seniority list:-**

After scrutinizing the details received through DCF Agrostology the name of Sh. Pawan Kumar, Watcher is incorporated in the final seniority list of Class-IV (MTS) at S. No 29 of Category "A".
