Whereas, the Tentative Seniority List of Class-IV officials of District Udhampur was issued vide this office Notification No. CFE/Estt/1996-99 dtd: 29.12.2023 born on cadre schedule as it stood on 04.06.2020 vide No. 713-17/CFE/Estt/J dated 02.08.2022 for inviting of objection with a period of 21 days if any.

Whereas, the following officials have filed their objections against the said tentative seniority list are as under: -

- 1. Representation of Sh. Surinder Kumar, Watcher of Udhampur Forest Division filed objection through DFO Udhampur vide No. 582/FDU dated. 09.05.2024 stated that his RBA category certificate need to be inclusion in the final seniority list of Class-IV (MTS) of Udhampur District.**

The representation of the official is considered and his name is placed at the RBA Category.

- 2. Representation of Sh. Shail Din, Mali received through Addl. Pr. Chief Conservator of Forests, Working Plan, J&K Jammu Office vide No. PCCF/WPRT/F-12II/1253-55 dtd: 04.12.2023 and CCF Jammu letter No. CCF-J/Estt/NG/C-IV/01-05 dtd: 01.01.2024 for incorporation of his name in the seniority list of District Cadre Udhampur.**

After scrutinizing the documents enclosed viz appointment order and Service Book, the official is appointed as Mali in Ramnagar Forest Division vide PCCF

Forest Order No. 125 OF 1998 dtd: 11.08.1998 and transferred to PI Division Jammu alongwith post vide PCCF Forest Order No. 484 of 2004 dtd: 10.12.2004 the applicant requested for inclusion his name in the seniority list of in his Parent Cadre of Ramnagar Division of Udhampur District as per SRO-124 of 03.04.2006 section 8 which is reproduced below.

“A member of the State/Divisional/District cadre will ordinarily be transferable within his own cadre:

Provided that in public interest he may be transferred to a post in any of the cadre, but his lien and promotion prospects shall be protected in his parent cadre”.

On the basis of above referred Order and SRO the representation of the official is considered and his name is placed at the appropriate place in the Combined final Seniority list of Class-IV (MTS).

3. Representation of Sh. Ashiq Nabi, Watcher, received through PCCF Office vide No. PCCF/NG/Estt/868-70 dtd: 05.08.2022 and for incorporation of his name in the seniority list of District Cadre Udhampur.

After scrutinizing the documents enclosed viz Regularization order and Service Book, the representation of the official is considered on the basis that the official appointed as Watcher, in Tikri Jungle Gali Project Udhampur vide Forest Order No. 07 of 1996 dated: 29.02.1996. the applicant approached to the Administrative Department for fixation of seniority and promotion benefit, the Pr. Chief Conservator of Forest vide letter No. PCCF/NG/Estt/1868-70 dtd: 05.08.2022 directed to get the report from DFO Udhampur Forest Division as to why his seniority has not been fixed among the class-IV employees in Udhampur Forest Division till date as the official was borne in the establishment at Project Office IWDP Tikri Jungle Gali Udhampur. DFO Udhampur vide letter no. 7421-25/FDU dtd: 31.10.2023 stated that the Tikri Jungle Gali Project was winded up by the Pr. CCF vide order No. 179 of 2008 dtd: 06.06.2008 with the direction that the Class-IV officials/Helper (if any) will continue to remain in Udhampur Forest Division. The representation of the official is considered and his name is placed at the appropriate place in the Combined final Seniority list of Class-IV (MTS).


