Whereas, the final seniority list of Senior Assists (UT cadre) was issued vide this office Forest Order No. 05 of 2024 dated 08-07-2024



This is issued without prejudice to the outcome of the Writ petition(s) pending, if any, on the subject before any competent Court of Law.
