Notification

Whereas, the final seniority list of Class-IV (MTS) of District Kathua was issued vide this office No. 629-35/CFE/J/Estt dated 20.07.2022.

Whereas, after the issuance of the said seniority list, some class-IV (MTS) official has retired from Govt. Service, and some have been promoted as Forest Guard.

Whereas, it has become imperative to update and notify seniority of Class-IV (MTS) by deleting the names of those who were promoted or retired from Govt. Service.

1. **Whereas, a representation of Sh. Sudesh Singh, Cleaner of Billawar Forest Division No. Nil dated 13.05.2024 with the request for inclusion of his name in the tentative seniority list of Cleaner of district Cadre Kathua.**

After scrutinizing the documents enclosed viz appointment order, Regularization Order and Service Book, the representation of the official is considered on the basis that the official initially appointed for the period of 89 days vide CCF Order No. 214 of 1998 dated 27.10.1998 in S.C. School Mirahsahib and after the expiry of 89 days the service of the official continued as Cleaner vide CCF order No. 82 of 2018 dated 24.04.2018 and joined in Billawar Forest Division. Accordingly, his name is placed at the appropriate place in the Tentative Seniority list of Cleaner of District Cadre Kathua.

Now, therefore, an updated Combined Tentative Seniority list of class-IV (MTS) as it stood on 22.05.2024 forming Annexure "A" and "B" to the Notification is hereby issued for information of all the concerned Class-IV (MTS) officials of district Kathua.

The Drawing and Disbursing Officer shall ensure that the tentative seniority list is circulated among all the Class-IV (MTS) Substantive and Supernumerary employees working under their Control so that they are apprised about their seniority position(s).

In case official(s) belonging to reserve category who desired to update the category status in the seniority list, they shall submit valid category Certificate, verified through their Drawing and Disbursing Officer.



The Date of Birth recorded against the officials in the tentative seniority list shall not be taken as authentic and shall always be subject to verification from Service Book/Date of Birth Certificate.

This is issued without prejudice to the outcome of the writ petition(s) pending if any, on the subject, before any competent Court of Law.




