Whereas, the final seniority list of Head Assistants of Forest Department was issued vide this office Forest Order No 55 of 2022 dated. 14-03-2022; and


Whereas, it has become imperative to update and notify the seniority of Head Assistants by deleting the names of those who were promoted to the next higher grade or have retired from Government service;
