Whereas, tentative seniority list of Junior Assistants (Divisional Cadre Kashmir) as it stood on 01-01-2024 was circulated vide notification bearing this office endorsement No:-CCF(K)/Admn/2023/Sen.JAs /Div.Cadre/ 2811-35 dated: 19-12-2023 read with No. CCF(K)/Admn/2024 /Sen.Jas/Div & Distt Cadre/32-51 dated: 04-01-2024 for information of all concerned;

Whereas, it was inter-alia provided in the abid notification:-

- That any Official not satisfied with his / her position in the tentative seniority list or the left out Junior Assistant(s), if any, may represent to this Office through his / her Drawing and Disbursing Officer with documentary evidence within a period of 21 days from the date of issuance of the notification. In case no representation was received within the stipulated time, it would be presumed that there was no objection to the position(s) assigned to the Official(s) in the tentative seniority viz-a-viz there was no left out incumbent and accordingly the seniority list would be finalized;
- That in case Official(s) belonging to reserve category/ies, were desirous to update the category status in the seniority list, he/she may submit the self-attested copy of valid category certificate through his/her drawing & disbursing Officer within the stipulated time period of 21 days;
- It was impressed upon the Junior Assistants appointed after III. issuance of SRO-272 of 2008 dated: 19th September, 2008 and who have qualified the Examination of SATC being held by the PSC, to submit self-attested copies of marks sheets of qualifying such examination, to this Office through their DDOs for up-dation at this end.

Whereas, the stipulated time period of 21 days has already expired and during the intervening time, no objection or representation has been received by this Office against the aforementioned tentative Seniority list of Junior Assistants of Divisional Cadre Kashmir. However, Mrs. Sumera Jan Junior Assistant submitted marks certificates of her having qualified the Foundation Course Departmental Examination through J&K Public Service Commission during March 2021 and accordingly, the same has been reflected in the relevant column of the final seniority list being issued under this Circular.
