Whereas, tentative seniority list of Junior Assistants (Divisional Cadre Kashmir) as it stood on 01-01-2022 was circulated vide notification bearing this office endorsement No:-CCF(K)/Admn/2022/Sen.JAs /Div.Cadre/26-50 dated: 01-01-2022.

Whereas, a time period of 21 days, from the date of issuance of the tentative seniority list, was provided to the concerned for filing of objections, if any.

Whereas, Shri. Ghulam Hassan Bhat Junior Assistant presently working in the Office of CF South Circle represented through his controlling officer (reference CF South Circle's letter No.CFS/2021-22/302 dated:20-01-2022) and pleaded for fixation of seniority above Ms. Sumera Jan (Serial No. 09) on the basis of his date of appointment viz 30-04-2016. A similar representation of the official was previously received from CF South Circle which was examined and the CF South Circle vide this Office letter No. CCF(K)/Admn/2021/2318 dated: 20-10-2021 was conveyed that the seniority of Junior Assistants (Divisional Cadre) had been finalized as per the existing rules. It was further conveyed to the CF South Circle that the request of Mr. Ghulam Hassan Bhat Junior Assistant is unacceptable and cannot be considered. It is pertinent to mention here that Miss. Sumera Jan has 68.00 points whileas Mr. Ghulam Hassan Bhat has 52.00 points in the selection list of Junior Assistants issued by the J&K Services Selection Board against the Advertisement Notification No. 09 of 2013 dated: 21-06-2013. Further, Rule -24(1) (b) of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules 1956 reads as under: -

"in the case of those recruited direct except those who do not join their duties when vacancies are offered to them according to the positions attained by and assigned to them in order of merit at the time of competitive examination or on the basis of merit, ability and physical fitness etc, in case no such examination is held for the purpose of making selections"

Now, therefore, the Final Seniority list of Junior Assistants (Divisional Cadre Kashmir) as it stood on 01-01-2022 forming Annexure to this Circular is issued for information of all concerned.

The Dates of Birth recorded against the Officials are provisional and are always subject to verification with original Date of Birth Certificate / Service Book.

The Drawing and Disbursing Officers shall ensure that the seniority list is circulated among all the Junior Assistants (Divisional Cadre Kashmir) working under their control so that they are apprised about their seniority position(s).
