Whereas, updated tentative seniority list of Divisional and District cadre Jr. Assistants of Jammu province as it stood on 31-08-2023 was circulated vide Notification No. 06 of 2023 dated 14-09-2023 under endorsement No. CCF-J/Estt/NG/1875-1903 dated 14-09-2023 and objections were invited.

Whereas, during the stipulated time period of 21 days, representations from various officials were received by this office directly/ through respective controlling officers which were examined on merit and extant rule position. All the representations have been addressed in light of records/ legal position and corresponding rectifications made accordingly along with some specific ones as per detail given as under:-

 Representation of Sh. Dhruv Singh, Jr. Assistant dated 25-09-2023 requesting therein for correction in his name and removal of remarks "Not confirmed by DPC":-

The representation dated 25-09-2023 submitted by Sh. Dhruv Singh has been considered and the remarks "Not cleared by DPC" as mentioned in the remarks column against his name in the seniority list of Jr. Assistants is being removed as the incumbent was temporarily promoted as Jr. Assistant vide PCCF's Office FO No. 37 of 1990 dated 25-01-1990 and subsequently confirmed as Jr, Assistant vide PCCF Office Forest order No. 103 of 1991 dated 27-06-1991 from the date he was appointed as Jr. Assistant i.e., 25-01-1990.

2. Representation of Sh. Dharam Chand, Jr. Assistant dated 04-10-2023:-

Sh. Dharam Chand has represented that his seniority be fixed above Smt. Madhu Bala and below Smt. Rishu Sharma i.e, 26-10-2009 also submitted that neither the seniority of the applicant has been fixed in light of PCCF J&K's direction of 24-11-2020 nor mentioned in the remarks column as reflected earlier

After scrutinizing the representation on the basis of record available in this office the official was appointed as Jr. Assistant in District cadre Jammu under SC category vide F.O No. 20 of 2011 dated 22-02-2011 as per the instructions conveyed by the Administrative Department vide No. FST/Coord/61/206-II dated 18-01-2011 alongwith the copy of letter of SSB/SEL/Secy/010/2595-99 dated 18-10-2010.Further, the case of Sh. Dharam Chand has already been taken-up with the Pr. CCF Office, J&K vide this office No. CCF-J/Estt/NG/955-56 dated 20-10-2020, in response to which the Pr. CCF's Office vide No. PCCF/Estt/NG/

93/477 dated 24-11-2020 issued instruction that "to fix the seniority of Sh. Dharam Chand Jr. Assistant of Divisional Cadre Jammu as per J&K Civil Services (Classification Control & Appeal Rules, 1956)".

The Rule 24 of J&K Civil Services (Classification Control & Appeal Rules, 1956) is recast as under:-

24. Seniority-(1) the seniority of a person who is subject to these rules has reference to the service, class, category or grade with reference to which the question has arisen. Such seniority shall be determined by the date of his first appointment to such service, class, category or grade as the case may be.

(Interpretation:- The words "date of first appointment occurring in the above rule will mean the date of first substantive appointment, meaning thereby the date of permanent appointment to the date of first appointment on probation on a clear vacancy. confirmation in the latter case being subject to good work and conduct or passing of any examination or examination and or tests.)

Further the Pr. CCF Office vide No. PCCF/Estt/NG/1454 dated 24-06-2022 conveyed that the matter of Sh. Dharam Chand, Jr. Asstt. was taken up with Finance Department in return Finance Department vide UO No. FD-Code/30/2021-03-268 dated 30-03-2021 advised as under:-

"The case has been examined in the Finance Department. The department is advised that all Government employees appointed or brought on regular establishment on or after 01-01-2010 shall be governed by SRO -400 of 2009 (New Pension Scheme").

Keeping in view the above facts, the seniority of the official has already been fixed at appropriate place and the corresponding entry already made against his name in the remarks column is deleted.

Representation of some Jr. Assistants for mentioning their SATC passed/qualifying 3. status against their names:

The corresponding entries have been made against the names of the incumbents as per the record available in this office.
