- 1. Representation of Sh. Chain Singh, Watcher & Sh. Babu Ram, Watcher received through CF Chenab Circle vide letter No. CFC/NG/2024-25/3737-39 dated 26.07.2024 & No. CFC/NG/2024-25/1934-36 dated 08.06.2024 respectively.**

The representation of the officials submitted to the O/o CCF, Jammu vide this office No. CFE-J/Estt/601-02 dated 31.07.2024 for further instruction in the matter which was further forwarded to the Pr. Order No. 213-FST of 2015 dated 19.08.2015 issued vide PCCF's letter No. PCCF/NG/Estt/Helper/134/2534-40 dated 27.08.2015 and accordingly his name is placed at the appropriate place in the Combined Final Seniority list of Class-IV (MTS) of District Cadre Jammu.

6. **Representation of Sh. Sat Pal, Peon received through DFO Udhampur vide No. 2387/FDU dated 06.08.2024 for incorporation of his name in the seniority list of District Cadre Jammu.**




