Whereas, a tentative Seniority list of Junior Assistants (State Cadre) has been circulated vide this office Circular issued under endorsement No PCCF/NG/ Estt/03/141-44 dated 16.01.2021 for inviting objects from the concerned officials with regard to their placement in the seniority list; and

Whereas, this office received 3 representation on the tentative Seniority list of Junior Assistants with regard to placement of Mrs. Shazia Khan Junior Assistant as she belongs to District Cadre Srinagar ; and


Whereas as per clause 8 of SRO-124 of 2006 a member of a cadre will not be transferred to a post in any other cadre. Even if such inter cadre transfers are done by the Government in public interest, the lien and promotion prospects shall be protected in his parent cadre. In effect, the parent cadre of an official cannot be changed under any circumstances and the official will continue his /her lien with the parent cadre and all promotion prospects shall be protected in the parent cadre; and

Whereas, Shri Tariq Ahmad Narwari, Junior Assistant has also furnished objection against the tentative seniority list of Junior Assistant wherein he has submitted that his name has wrongly be shown as 'Tariq Ahmad Narwari' instead of 'Tariq Majid Narwari'.

In light of the above, it is hereby ordered that:-

- (a) the name of Mrs.Shazia Khan, Junior Assistant is deleted from the seniority list of Junior Assistants of the State Cadre as the official belongs to District Cadre Srinagar.
- (b) The name of Mr.Shazia Khan, Junior Assistant to be included in the seniority list of District cadre Srinagar, her parent Cadre by the Cadre controlling Authority.
- (c) In the name of Shri Tariq Majid Narwai, Junior Assistant is rectified as requested and on the basis of records.

Accordingly, the Final Seniority list of Junior Assistant (State Cadre) as it stood on 1.1.2021 forming Annexure-"A" to this Forest order is hereby issued.


