The Drawing and Disbursing Officers shall ensure that the seniority list is circulated among all the Drivers Grade-II (Junior Grade) working under their control so that they are apprised about their seniority position(s). *The Seniority list shall be finalized after taking into consideration the decisions / recommendations of the Divisional Level Departmental Promotion Committee scheduled to be held on December 23rd 2023.*
