


OFFICE OF THE, CHIEF CONSERVATOR OF FORESTS, KASHMIR.

In case Official(s) belonging to reserve category/ies, are desirous to update the category status in the seniority list, he may submit the self attested copy of valid category certificate through his drawing & disbursing Officer within the stipulated time period of 21 days.

The Dates of Birth recorded against the Officials are provisional and are always subject to verification with original Date of Birth Certificate / Service Book.

The Drawing and Disbursing Officers shall ensure that the seniority list is circulated among all the Drivers Grade-II (Junior Grade) working under their control so that they are apprised about their seniority position(s). The Seniority list shall be finalized after taking into consideration the decisions / recommendations of the Divisional Level Departmental Promotion Committee scheduled to be held on December 23rd 2023.
