Whereas, the final seniority list of Head Assistants of Forest Department was issued vide this office Forest Order No 32 of 2023 dated. 13-02-2023;



This is issued without prejudice to the outcome of the Writ petition(s) pending, if any, on the subject, before any competent Court of Law.


